General information

- This application form is only for domestic students. Only Australian citizens, Australian permanent residents and citizens of New Zealand should use this form to apply. Other applicants should contact the International Office on (+612) 8627 8300 or at info@io.usyd.edu.au for application materials and assistance.
- Complete the application form using BLOCK LETTERS, and where required, write clear crosses in the appropriate boxes.
- Please ensure that the information on your application is complete, that all of the required documentation is included and that the application is legible. Incomplete or illegible applications may be delayed.
- If you wish to be considered for an undergraduate course which is offered through the Universities Admissions Centre you should not use this form to apply. You should apply through the Universities Admissions Centre (www.uac.edu.au) by the last working day in September. If you wish to apply for a course which is not offered through UAC you may use this application form. If you have been enrolled in an undergraduate course at the University and you wish to be re-admitted into that course you may be able to use this form to apply. Please check with your faculty about the process for re-admission.

Supporting documentation

- You are required to provide documentation in support of this application. If you do not attach all of the documents required by the faculty, your application may not be considered. The documents you may have to provide include:
 - * evidence of your residency status,
 - * proof of change of name,
 - * academic transcripts for your secondary and/or tertiary qualifications,
 - * evidence of English proficiency,
 - * information about your record of exclusion,
 - * evidence of permission from another institution for you to enrol as a cross-institutional student,
 - * a statement from a professional body recommending that you undertake non-degree study in order to meet their membership requirements.

There is information on the application form about the circumstances under which you must provide documentation. You should provide originals wherever possible, especially of academic documents such as transcripts and English test result notices. Faculty and Student Centre staff can sight original documents and copy them for you so that you need not submit originals with your application. If you have questions about which types of documents are acceptable in support of your application, or whether or not original documents can be returned to you after your application has been processed, you should contact your faculty.

- If your supporting documents are not in English you must provide translated versions of those documents in addition to certified copies of the originals. These translations should be official. Some examples of the types of translations which may be accepted are those produced by the Community Relations Commission (CRC), the Department of Immigration and Citizenship (DIAC), or by an accredited National Accreditation Authority for Translators and Interpreters (NAATI) translator of at least 'Translator' or 'Level 3' status. Please note that if you are providing copies of translations, rather than originals, those copies must also be certified.

Making inquiries and submitting your application

- You must direct any inquiries you have about your application to the undergraduate adviser of the faculty concerned.
